Introduction

This version follow-up report provides information on what has been changed in the Multilinks Database on Intergenerational Policy Indicators over time. The report enables users to trace back through all of the changes made to the database since it was first published in September 2011 (version 2.0).

The Multilinks Database on Intergenerational Policy Indicators is continuously monitored and updated. Errors in the data set, information from more reliable sources, new indicators and updates are integrated into the database from time to time. For each renewed upload of data onto the Internet, a new version is set up. The version designation consists of two numbers. The first number indicates how many reference years are included (two at the moment). The second number shows how many relaunches of the database have been made to up date the data without adding a new reference year (at the moment one).

A relaunch of the database means that all files and documents (database, data sets for statistical analysis, methodological report, code-book) have been revised and updated. These files and documents always refer to the most recent version of the database; it is not possible to follow up changes from these sources. In the version follow-up report, however, all entries from former versions of the database are shown. Most of the changes made are documented. This report is a useful tool for controlling whether the data from a previous database version that have been used in publications or statistical analysis are still up to date. For each indicator there is a report table in which changes are documented.

The version follow-up report documents all changes of indicator values, indicator definitions, and data sources. Changes to general comments and country-specific comments are reported only if the content has changed substantially. Furthermore, all extensions of an indicator, such as a new reference year or further country information, are documented. Corrections of spelling, layout and the like are not listed.

Version characteristics

The following paragraphs describe the main features of the published versions and document substantive changes.

Version 2.0

This version is the first publicly available version of the Multilinks Database on Intergenerational Policy Indicators.¹ Published in September 2011, version 2.0 for the first time includes information for two reference years: 2004 and 2009. There are 76 indicators included in the database for 30 European countries.

Version 2.1

In this subversion some reorganisation at the level of subthemes has been made. There are four new indicators on the level of child allowances. To reduce the number of indicators per subtheme the former subtheme on child allowances are subdivided into two subthemes, one on eligibility conditions and one on the level of child allowances. Another new subtheme has been introduced. The two indicators on credited non-contribution periods for caring in public pension schemes are headed under a new subtheme: recognition of care work.

Seven indicators have been newly introduced:

- School holidays per school year
- Effective retirement age of men
- Effective retirement age of women
- Child allowance per child in euro – 1 child
- Child allowance per child in euro – 3 children
- Child allowance for 1 child as a share of net average income
- Child allowance for 3 children as a share of net average income
